## REGULATIONS FOR BEING ON BOND

- 1. Check in is every <u>Wednesday</u>. Check in is done through the Bailtec Client App, or in person at the office. The Bailtec Client app is available on both IPhone and Android Platforms. The email address you provided us is your username, and we will provide you with the password.
  - \*\*\* If I miss 2 check ins in a row, I willingly forfeit my bond and Aggieland/Big Mama's Bail Bond may surrender my bond to the court who may then issue a warrant for my arrest or pay \$25.00 to Aggieland/ Big Mama's Bail Bonds to keep me on bond.
- 2. I am not to leave the jurisdiction of the court without Aggieland/Big Mama's Bail Bonds consent. I am to call them **BEFORE** I leave and upon return.
- 3. I will not commit any acts which shall constitute reasonable evidence of intention to forfeit my bond(s). This includes giving false information in this application. Or Moving without notice and leaving the State of Texas.
- 4. I am not to be arrested for anything else other than minor traffic violations while on bond.
- 5. If I am on a payment plan, I must make every effort to make my payments on or before the payment is due. If I miss 2 payments without notifying Aggieland/ Big Mama's Bail Bonds or more than 3 payments without a new written agreement from them I willingly forfeit my bond and Aggieland/Big Mama's may surrender my bond(s) to the court who may then issue a warrant for arrest. We do add late charges of \$35.00 per late payment.
- 6. It is my responsibility to keep track of my court dates. I am to notify Aggieland Bail Bonds when I receive them in the mail.
- 7. I am to notify Aggieland Bail Bonds/Big Mama's Bail Bond and the Court of any and all changes of: Address, Employer, Telephone Number or Attorney.
- 8. I must provide Aggieland Bail Bonds/ Big Mama's Bail Bonds written documentation that my case has been dismissed or disposed of by bringing to the office any judgement or orders signed by the JUDGE.
- 9. If I violate this bond agreement by failing to appear in court, I understand that I will not only be responsible for the full amount of the bond. I will also be responsible for paying the cost of location and apprehension (usually 25% of the bond) and a penalty in the amount of 20% of my bond(s).

I acknowledge this agreement and agree to abide by these regulations. If I do not, I give Aggieland/ Big Mama's Bail Bonds permission to surrender my bond(s) to the court who then may issue a warrant.
